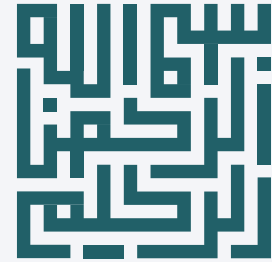

A/ Technical Requirements





1. Coaches

- 1.1 Holds a bachelor's degree in sports education (cycling).
- 1.2 Holds a bachelor's degree and has previously represented the national team and has an advanced training certificate from the National Federation.





2. Facilities

- 2.1 Provide a headquarters for the academy.
- 2.2 The headquarters must contain (management offices - mechanics workshop - bicycle warehouse - changing room and toilets)
- 2.3 should have electric, water and internet.
- 2.4 Adherence to conditions on municipality and Civil Defense





3. Equipment

- 3.1 Specialized bicycles (Road – Mountain-Track-Bmx).
- 3.2 Provide of cycling clothing by type (individual road - individual against the clock- mountain).
- 3.3 Helmet & head protection , special shoes, gloves, socks.
- 3.4 Training devices.
- 3.5 Reflective clothing and Front , Back light.





4. Safety

- 4.1 A car to protect players from behind during exercise with a (warning siren)
- 4.2 Motorcycle equipped (warning siren) to accompany players during exercises.
- 4.3 No exercise permitted on highways.
- 4.4 Staying in the right lane during exercises.
- 4.5 Abiding by traffic signals.
- 4.6 Full stop on the traffic signal .
- 4.7 Do not reverse the road and drive on pedestrian on public parks.
- 4.8 Adhere to the traffic system.
- 4.9 Upon acceptance of the player, the player is required to submit a medical examination stating that the participant is medically fit and the academy is held the full responsibility for that.

4. Safety

4.10 Having a certified physiotherapist for the team or a valid contract with a clinic from the Saudi Federation for Health Specialties. In the event that a specialist is available but not accredited, one can apply for accreditation by filling out the following form by the Saudi Federation for Sports Medicine (SFSM)

4.11 First Aid - Provide first aid kit with adequate equipment as it's stipulated here <http://sfsm.org.sa/mos70> as per SFSM's minimum standards, and to have an ambulance car during games & tournaments (if available).

4.12 Fire alarm system according to the requirements of the Civil Defense



5. Competition

- 5.1** Academies are entitled to participate in races in accordance with the approved technical regulations.
- 5.2** The Saudi Arabian Olympic Committee and Federations issues the conditions and instructions regulating the internal and external participations, whether in training camps, tournaments or competitions, and circulates them to the sports federations to work in accordance with them.
- 5.3** Categories participating in competition:
- A. Adults aged 19 years and over
 - B. Young aged between 17-18 years old.
 - C. Junior aged between 15-16 years old.
 - D. Kids between 12-14 years old.

6. Membership

- 6.1** Membership and its requirements. (The membership mechanism and the link of the federation with requirements and conditions (if any) are placed here.
 - 6.1.1** - The executive and financial regulations for the new activity.
 - 6.1.2** - A statement that includes the existing facilities, stadiums and equipment.
 - 6.1.3** - Declaration of commitment to the regulations, decisions and regulations issued by the Federation.
 - 6.1.4** - Any requirements that the Federation deems necessary.
 - 6.1.5** - Receipt of payment of the number set for joining the Federation membership.
 - 6.1.6** - A statement of the names, qualifications and experiences of the technicians and supervisors of the activity and the game.
- 6.2** An applicant for membership is considered a member of the federation from the date of issuance of the board of directors 'decision.
- 6.3** In the event that the request is rejected by the Board of Directors, the decision must be justified, and the applicant for membership has the right to appeal the decision to the Olympic Committee within fifteen days from the date of his notification of the decision and its decision is final
- 6.4** If the applicant for membership is not notified of the decision of the board of directors during the periods referred to in the previous paragraphs, then he is entitled to refer the matter to the committee.
- 6.5** Add the project plan



7. Fees

- 7.1** The academy will be responsible for the expenses for the team and the expenses of participating in the races.
- 7.2** Academy Affiliation fee (SR 15,000) is deposited in the Saudi Cycling Federation account (the Academy is not eligible to enter the general assembly of the Federation).





8. Violations & Penalties
