A/ Technical Requirements







#### 1. Coaches

- 1.1 Coach must register and approved from Saudi Esports Federation.
- 1.2 Pass the interview
- 1.3 must be over 18 years of age





#### 2. Facilities

**2.1** Club facility for training, or partner up with Saudi Esports federation registered gaming center as club facility and must be over 50m3





#### 3. Equipment

- **3.1** Provide 6 PC setup and it's equipment (minimum 16 GB Ram, minimum 1.8 ghz CPU speed, minimum 6 GB graphics card, minimum 144hz 24inch monitor, headset, mouse,keyboard, mousepad, chair, table) if a club registered in a game
- 3.2 Provide minimum 2 Playstations if a club registered in a game.
- **3.4** Provide minimum 2 XBOX if a club registered in a game.
- 3.5 Provide minimum 2 Nintendo if a club registered in a game.
- 3.6 Provide a minimum 100Mbps internet connection.





#### 4. Safety

**4.1** Upon acceptance of the player, the player is required to submit a medical examination stating that the participant is medically fit and the club is held the full responsibility for that.

**4.2** Having a certified physiotherapist for the team or a valid contract with a clinic from the Saudi Federation for Health Specialties. In the event that a specialist is available but not accredited, one can apply for accreditation by filling out the following form by the Saudi Federation for Sports Medicine (SFSM) http://sfsm.org.sa/mos30

**4.3** First Aid - Provide first aid kit with adequate equipment as it's stipulated here <a href="http://sfsm.org.sa/mos70">http://sfsm.org.sa/mos70</a> as per SFSM's minimum standards, and to have an ambulance car during games & tournaments (if available).

### 5. Competition

- **5.1** Register games in Saudi eLeagues
- **5.3** The Saudi Arabian Olympic Committee and Federations issues the conditions and instructions regulating the internal and external participations, whether in training camps, tournaments or competitions, and circulates them to the sports federations to work in accordance with them.

# B/ Administrative Requirements







#### 6. Membership

- **6.1** The obligation to represent the country in regional, continental and international participations after the approval of the Federation.
- **6.2** Commitment to the participation of selected players in the preparation and official participation programs for national teams.

#### 6.3 An active member is entitled to the following:

- Participate in all Federation activities.
- 2. Attendance and participation in the General Assembly meeting, provided that six (6) months have passed from the date of obtaining the active membership.
- Peruse the decisions issued by the Federation.
- 4. Receive basic information on the Federation's activities periodically.
- An active member may address the federation through any available means, and the board of directors or the executive management must provide the answer through the same means or through his address registered in the membership register.





#### 6. Membership

#### 6.4 Club can be member if he fulfills the following conditions:

- a. To be a club with a legal personality.
- **b.** To have a license to practice esports from the Ministry and the Federation.
- c. He must have paid the fees approved by the Federation.
- d. To participate by 50% in the Federation's activities.
- e. The member must have:
- **f.** Payment of membership fees as determined by the Board of Directors.
- g. Pay the annual renewal fees for the active membership, as determined by the Board of Directors.
- **h.** Work to achieve the Federation's goals and keep away from what harms its entity or harms its reputation.
- i. Adhere to the internal system and regulations and implement the decisions of the General Assembly and the Board of Directors.
- **J.** Respect for principles, values, traditions, customs and sportsmanship.
- **k.** Commitment to participate in the Federation's activities.





#### 7. Fees

7.1 There is no fee



#### 8. Violations & Penalties

- **8.1** Violations and penalties that may be inflicted in the event of non-compliance with the rules and regulations of the Federation::
  - 1. Written warning.
  - 2. A fine
  - 3. Suspending the license
  - 4. Other penalties sanctioned by the Federation
